

Mahomet Township
Tax Levy Ordinance
Ordinance No. 2/24-25

An ordinance levying taxes for all towns purposes for Mahomet Township, Champaign County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the board of Trustees of Mahomet Township, Champaign County, Illinois as follows:

SECTION 1: That a sum of Four Hundred Nineteen thousand seven hundred forty-one dollars, (\$419,741) are hereby levied upon all property subject to taxation withing the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund

IMRF Fund

Cemetery Fund

General Assistance Fund

For the year 2025.

Section 2: That the amount levied for each object and purpose shall be as follows:
