Cameron Wygant- Comments regarding November 12, 2025 meeting.

He has concerns that the Supervisor does not communicate spending to the Trustees

Ex. 2 new vehicles purchased recently, 2 mowers, 1 new truck- claims all were purchased 2 to 3 days after meeting and was not mentioned. No line item in budget. He claims the spending is "out of control". He FOIA'd bills from the Village and Sangamon Valley Public Water District and their attorney bills are much less than the Township. He also mentioned a building permit for a building estimated to cost over \$300,000. He also mentioned that on Aaron's way out the door last month, he claimed that Cameron is costing the taxpayers money. Cameron dropped papers on the table and said this is what Aaron cost in attorney bills.

Nick Ponder- background in elementary education. Wanted to address the temperament of the last meeting. He challenged the Trustees to do better. He claimed the behavior in the last meeting was "embarrassing"

John Bambenek- Illegal use of the Road fund. He suggested having a special meeting to fix the Mahomet Township Road District tax levy. He also claimed that he had sent a FOIA to

the MTRD and in the response, he saw a bill from a law firm- Cline, Foyd and Jenkins dated August 13, 2025 that listed Chris Doenitz on the billing. John questioned who is making the decisions at the road district? Jackson responded that he is.
