An Ordinance Appropriating for All Town Purposes

An ordinance appropriating for all town purposes for **Mahomet Township**, Champaign County, Illinois, for the fiscal year beginning **April 1, 2026**, and ending **March 31, 2027**.

BE IT ORDAINED by the Board of Trustees of Mahomet Township, Champaign County, Illinois:

SECTION 1

That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Mahomet Township, be and the same are hereby appropriated for the town purposes of Mahomet Township, Champaign County, Illinois, for the fiscal year beginning April 1, 2026 and ending March 31, 2027.
